PAYMENT

- 1. Upon signing up for this trip, each participant is required to pay a non- refundable registration fee of CAD \$300.
- 2. Upon signing up for this trip, each participant is required to pay a deposit of CAD \$500.
- 3. Deadline for complete payment of CAD \$500 is due on **October 10th, 2010**
- 4. Deposit may be fully refunded 75 days before the commencing of the Personal Growth 2010 trip.
- 5. Payment must be in the form of CASH or CHEQUE payable to the INTEGRATION YOUTH SERVICE SOCIETY.

REFUND POLICY

- 1. In a written letter format, notify the Integration Youth Service Society of the cancellation of such trip.
- 2. Refund 50 days or more before the commencement of the trip will be the loss of 100% of the deposit.
- 3. Refund 31 - 49 days before the commencement of the trip will be the loss of 50% of the Entire Tour Fees.
- 4. Refund 30 days or less before the commencement of the trip will be the loss of the Entire Tour Fees.

TRIP DETAILS:

1. The total land cost is CAD \$1000 (\$200 Donation included). This cost includes the following: transportation , accommodations, food and local tour. DOES NOT include: China Visa, insurance, personal expense, and any other expenses not stated in the included section.
